# Special Resolution BTC Constitution for consideration AGM 4:30pm, Saturday 14 May 2022.

#### SPECIAL RESOLUTION:

For Members to consider and pass the following Special Resolution:

"That, in accordance with the requirements of the Associations Incorporation Act 2015 (WA), the Constitution contained in this draft be approved and adopted as the Constitution of the Busselton Tennis Club (Inc) in substitution for, and to the exclusion of the existing Busselton Tennis Club (Inc) Constitution."

### **Background:**

A Busselton Tennis Club Task Force was asked to deal with the review of the Constitution as recommended in the Strategic Directions document and worked diligently to provide the Management Committee with their findings. In turn, the Management Committee reviewed those findings and has made some adjustments for the Memberships consideration.

By way of general background, the existing BTC Constitution had been partly updated on numerous occasions over the past few years. This resulted in a number of confusing inconsistencies. The current Constitution was last amended in May 2019.

The primary aim of the Taskforce was to streamline and simplify the Constitution so that it fulfilled the legislative requirements of the State Government but removed unnecessary operational details about the day-to-day running of the Club that could be dealt with and updated elsewhere. A Constitution is a legally binding document that must be consistent with *Associations Incorporation Act 2015 (WA)*.

In broad terms, a Constitution is the document that Members and their delegated Management Committee agree reflects the principles by which the association should operate. It is not intended to be a detailed plan of that operation. A Constitution needs to be written in such a way that it allows the organisation to grow and develop over many years and not need to be substantially changed. All other Club documents must be subsidiary to the Constitution.

Details about how the day-today running can be done via Club By-laws, Procedures, Policies and Regulations. These can be adjusted as necessary without making changes to the Constitution as long as they are consistent with it.
